

Safe Patient Care (Nurse to Patient and Midwife to Patient Ratios) Bill 2015

The Safe Patient Care (Nurse to Patient and Midwife to Patient Ratios) Bill 2015 was introduced to Parliament on 1 September 2015 and the *Safe Patient Care (Nurse to Patient and Midwife to Patient Ratios) Act 2015* (the Act) took effect from 23 December 2015.

The purposes of the Act is to confirm the minimum requirements for:

- nursing and/or midwifery staffing ratios in public health services; and
- the associated compliance reporting.

Previous Amendments included the requirement for health services to make a public disclosure related to their mixed wards and birthing suites.

Amendments to the Act were last implemented on 1 July 2023

Amendments to the Regulations reflect current practices and provide consistency across hospitals as to the criteria and requirements services must considered in determining appropriate staffing requirements for the delivery of safe and quality care.
